# GUIDELINES, TERMS & CONDITIONS

#### **HOW TO ENTER**

Enter your details by filling out the online Google form and upload your photograph(s) to the SSNI website: <a href="mailto:ssni.co.in/world-fisheries-day/">ssni.co.in/world-fisheries-day/</a>.

Photos of any Indian coastline, marine fisheries and well-managed fishing practices among coastal communities as subject matter will be accepted.

Multiple entries are welcome but each submitted photo may only be entered into one of the three categories.

#### **ELIGIBILITY**

The Photographic Competition is open to everyone, except SSNI and MSC contracted staff members and their immediate family. Participants need to be 18 years of age or older at time of entry.

Photographers from any country in the world are invited to enter, however the photos must have been taken in India.

### CAMERA SPECIFICATIONS & FILE TYPE

Any type of camera or cell phone may be used to create images, however it is recommended that the highest available image quality setting is used. It should be noted that most of the judging criteria will be focused on the composition of the image.

Photos must be submitted in digital JPEG format with a maximum size of 2MB, however if your photograph is shortlisted you may be required to supply a higher quality image and to provide a suitable caption.

#### NOTE ON PHOTO MANIPULATION

Post-processing of images is allowed. This includes global adjustments to exposure, contrast, burning, dodging, cropping, sharpening, noise reduction, and tone. Minor cleaning of images is permitted, including the removal of backscatter, dust and scratches. HDR, panoramas, focus stacking or other techniques that involve using multiple images taken at the same time and place are also allowed.

Adding, removing or moving animals, people, plants or other objects are not allowed. For example, moving a fish or removing a reef element is not acceptable. All

images should accurately represent the subject matter and nature. Images that appear to be overly processed may be disqualified at the judges' discretion.

#### **ENTRY TERMS & CONDITIONS**

SSNI and MSC have the right to reproduce your photo in any format, including print products, on the web, and in social media without compensation.

By entering the competition, you are giving consent to SSNI and MSC to use and reproduce the image for future promotion of its activities and at events. Photographers will retain credit for their entries. This photograph should not be used for any other purpose.

This is a public photographic competition. The judges' decision is final and no correspondence will be entered into.

By submitting a photograph to this competition, you:

- Declare that you own the copyright of the photograph and that it is your original work (or submitted with permission).
- Declare that you have permission to use the visual image of any identifiable individual or building in the photograph for entry into the competition and that the image may be published as stipulated in the photo contest rules.
